

# INSTRUCTIONS

## Entry and exit for pleasure sailors of third countries - including the United Kingdom



### General information

Boat owners and their crew are exempt from the EES (Entry/Exit System).

No biometric data, such as fingerprints or facial images, is required when entering through a marina.

Pleasure boat owners who are not citizens of the European Union or the Schengen Area must complete the border police form and e-mail it to the marina reception that will be either the first port of call or the final port of departure.

### Required procedure for entering Europe via Cherbourg

- > Complete the official border police form (also available on Port Chantereyne website or on request).
- > Send the form by e-mail to the marina reception : **portchantereyne@cherbourg.fr** ideally **24 hours** before arrival **and** departure from Cherbourg. Only one form is required per boat. The marina reception will forward the form to the border police.

The same procedure applies for entry into Europe **and** exit from Europe. However, if pleasure boaters and their crew have used the biometric registration method, e.g. when arriving by ferry, they must report to the border police office to complete their exit formalities.

### Inspection

Upon receipt of the form, the border police may carry out checks where necessary.
